ABOUT THIS REPORT

Our Drinking Water meets or exceeds all Federal and State Drinking Water Requirements. This report is a summary of the quality of the water we provide our customers. The analysis was made by using the data from the most recent U.S. Environmental Protection Agency (EPA) required testing. We hope this information helps you become more knowledgeable about what is in your drinking water.

SPECIAL NOTICE FOR THE ELDERLY, INFANTS, CANCER PATIENTS, PEOPLE WITH IMMUNE PROBLEMS

You may be more vulnerable than the general population to certain microbial contaminants, such as Cryptosporidium, in drinking water. Infants, some elderly, or immunocompromised persons such as those undergoing chemotherapy for cancer; persons who have undergone organ transplants; those who are undergoing treatment with steroids; and people with HIV/AIDS or other immune system disorders, can be particularly at risk from infections. WHERE DO WE GET OUR WATER?

Emerald Forest Utility District receives water from three sources:

- Groundwater from two wells within the Evangeline aquifer located in Harris County,
- Surface water purchased from North Harris County Regional Water Authority (NHCRWA),
- Groundwater from Harris County Fresh Water Supply District (FWSD) 61 (Chicot aquifer) to some of the retail establishments within the district and
- A blend of ground and surface water from Reid Road MUD 1, as needed. However, during 2024, Reid Road MUD 1 did not supply water to Emerald Forest UD.

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. To ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. Contaminants may be found in drinking water that may cause taste, color or odor problems. The presence of contaminants does not necessarily indicate that water poses a health risk. FDA regulations establish limits for contaminants in bottled water which must provide the same protection for public health. The Texas Commission on Environmental Quality (TCEQ) completed an assessment of your source water, and results indicate that our sources have a low susceptibility to contaminants. The sampling requirements for your water system are based on this susceptibility and previous sample data. Any detections of these contaminants will be found in this Consumer Confidence Report (CCR). DRINKING WATER CONTAMINANTS

Contaminants that may be present in source water include:

- **Microbial contaminants**, such as viruses and bacteria, may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- **Inorganic contaminants**, such as salts and metals, can be naturally occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- **Pesticides and herbicides**, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems.
- Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.

ARSENIC

While your drinking water meets the EPA's standard for arsenic, it does contain low levels of arsenic. The EPA's standard balances the current understanding of arsenic's possible health effects against the costs of removing arsenic from drinking water. The EPA continues to research the health effects of low levels of arsenic, which is a mineral known to cause cancer in humans at high concentrations and is linked to other health effects such as skin damage and circulatory problems.

DRINKING WATER CONTAMINANTS - CONT'D

LEAD

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Emerald Forest Utility District is responsible for providing high quality drinking water but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. SECONDARY CONSTITUENTS

Many constituents (such as calcium, sodium, or iron) which are often found in drinking water, can cause taste, color and odor issues. Taste and color constituents, called secondary constituents, are regulated by the state of Texas, not the EPA. These constituents are not causes for health concern. Therefore, secondary constituents are not required to be reported in this document, but they may affect the appearance and taste of your water. TURBIDITY

Turbidity of surface water from has no health effects, but it is monitored because it is a good indicator of the effectiveness of the surface water plant filtration system. Turbidity can interfere with disinfection and provide a medium for microbial growth. High turbidity may indicate the presence of disease-causing organisms. These organisms include bacteria, viruses, and parasites that can cause symptoms such as nausea, cramps, diarrhea, and associated headaches. Your water is also tested monthly for disease-causing bacteriological microbes.

WATER QUALITY DATA

The state of Texas allows for some contaminants to be monitored less than once per year because the concentrations do not change frequently. The year that each result was detected is indicated in the tables below. Definitions, abbreviations, and sources of detected contaminants can be found on pages 10 and 11 of this report.

IMPORTANT INFORMATION ABOUT YOUR DRINKING WATER

Monitoring Requirements Not Met for Emerald Forest Utility District

Our system failed to collect every required coliform sample. Although this incident was not an emergency, as our customers, you have a right to know what happened and what we did to correct this situation.

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. During August 2024 we did not complete all testing for coliform bacteria and therefore cannot be sure of the quality of your drinking water during that time.

What should I do?

There is nothing you need to do at this time. You may continue to drink the water. If a situation arises where the water is no longer safe to drink, we are required to notify you within 24 hours.

What is being done?

We collected every required coliform sample in August 2024 and are no longer in violation.

DEFINTITIONS AND ABBREVIATIONS

Action Level (AL)	The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.			
Avg	Regulatory compliance with some MCLs is based on running annual average of monthly samples.			
Level 1 Assessment	A study of the water system to identify potential problems and determine (if possible) why total coliform bacteria have been found in our water system.			
Level 2 Assessment	A very detailed study of the water system to identify potential problems and determine (if possible) why an E. coli MCL violation has occurred and/or why total coliform bacteria have been found in our water system on multiple occasions.			
Maximum Contaminant Level (MCL)	The highest level of contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.			
Maximum Contaminant Level Goal (MCLG)	The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.			
Maximum residual disinfectant level (MRDL)	The highest level of disinfectant is allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.			
Maximum residual disinfectant level goal (MRDLG)	The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.			
μg/L	Micrograms per liter = ppb; This unit indicates the amount of a substance (in micrograms) dissolved or present in one liter of a liquid.			
mg/L	Milligrams per liter = ppm; This unit indicates the amount of a substance (in milligrams) dissolved or present in one liter of a liquid.
