SPECIAL NOTICE FOR THE ELDERLY, INFANTS, CANCER PATIENTS, PEOPLE WITH IMMUNE PROBLEMS

You may be more vulnerable than the general population to certain microbial contaminants, such as Cryptosporidium, in drinking water. Infants, some elderly, or immunocompromised persons such as those undergoing chemotherapy for cancer; persons who have undergone organ transplants; those who are undergoing treatment with steroids; and people with HIV/AIDS or other immune system disorders, can be particularly at risk from infections. INFORMATION ABOUT YOUR DRINKING WATER

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Contaminants that may be present in source water include:

- **Microbial contaminants**, such as viruses and bacteria, may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- **Inorganic contaminants**, such as salts and metals, can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- **Pesticides and herbicides**, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, are byproducts of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems.
- Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

Contaminants may be found in drinking water that may cause taste, color, or odor problems. These types of problems are not necessarily causes for health concerns. For more information on taste, odor, or color of drinking water, please contact the system's business office.

WHERE DO WE GET OUR DRINKING WATER?

Emerald Forest Utility District provides ground water from the Evangeline aquifer located in Harris County. Emerald Forest also purchases water from North Harris County Regional Water Authority. Finally, Emerald Forest receives water from Harris County Fresh Water Supply District (FWSD) 61 to some of the retail establishments within the district. The Texas Commission on Environmental Quality (TCEQ) completed an assessment of your source water, and results indicate that our sources have a low susceptibility to contaminants. The sampling requirements for your water system are based on this susceptibility and previous sample data. Any detections of these contaminants will be found in this Consumer Confidence Report (CCR). ^{**}If present, elevated levels of lead can cause serious health problems, especially for pregnant women and your children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. This water supply is responsible for providing high quality drinking water but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Turbidity has not health effects but it is monitored because it is a good indicator of the effectiveness of the surface water plant filtration system. Turbidity can interfere with disinfection and provide a place for microbial growth. High turbidity may indicate the presence of disease-causing organisms. These organisms include bacteria, viruses, and parasites. Your water is also tested monthly for disease-causing bacteriological microbes.

Your drinking water meets or exceeds all federal and state drinking water requirements.

DEFINTITIONS AND ABBREVIATIONS

Action Level (AL) – The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Avg – Regulatory compliance with MCLs is based on running annual average of monthly samples.

Maximum Contaminate Level (MCL) – The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal (MCLG) – The level of a contaminant in drinking water below which there is no known or expected health risk. MCLGs allow for a margin of safety.

Maximum Residual Disinfectant Level (MRDL) – The highest level of disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

Maximum Residual Disinfectant Level Goal (MRDLG) –The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contamination.

Treatment Technique (TT) – A required process intended to reduce the level of a contaminant in drinking water.

NA – MCL not applicable – not regulated.

NTU – Nephelometric Turbidity Units (a measure of turbidity)

MFL – million fibers per liter (a measure of asbestos)

pCi/L – Picocuries per liter, (a measure of radioactivity). One pCi/L is equivalent to two atoms disintegrating per minute per liter.

ppm – Milligrams per liter or parts per million, or one ounce in 7,350 gallons of water

ppb – Micrograms per liter or parts per billion, or one ounce in 7,350,000 gallons of water
