## HARRIS COUNTY MUNICIPAL UTILITY DISTRICT NO. 230

## Park Rules

Within the limits of any of the Harris County Municipal Utility District No. 230 (the "District") parks and recreational facilities (collectively, the "Parks"), the following rules apply, except as may be otherwise provided by prior written permission from the District:

- 1. Public park areas are open from dawn to dusk (this includes trail, playground, gazebo, and common areas in the Parks). Entering or using the Parks at any other time is prohibited without prior approval by the District.
- 2. Pets must be on a leash (not more than 6 feet long) at all times while utilizing the Parks. Owners must clean up all solid waste deposited by their animal(s).
- 3. No horses or livestock are permitted in the Parks unless utilized for security patrol as directed by the District.
- 4. Swimming, wading, or boating is prohibited.

- 5. Motorized vehicles and skateboards are prohibited in the Parks unless utilized for security patrol or maintenance as directed by the District.
- 6. Damaging or defacing any park property or natural resources including, but not limited to, structures, monuments, water features, and vegetation is prohibited. Do not hunt, kill, molest, frighten, or tease any animals, reptiles, or birds in the Parks.
- 7. Alcoholic beverages, glass containers, and littering are prohibited in the Parks.
- 8. Fireworks, carrying firearms (except by those persons duly authorized and licensed by the state to carry a concealed handgun in accordance with the provisions of the Texas Concealed Handgun Act), and/or discharging firearms are prohibited in the Parks.
- 9. Patrons must dispose of trash in trash receptacles in the Parks.
- 10. Driving or parking outside of designated parking areas is prohibited.
- 11. Abusive or offensive language in the Parks is prohibited.
- 12. Advertising or soliciting in the Parks is prohibited without prior approval by the District.
- 13. Selling of any concession items or services in the Parks is not permitted without prior approval by the District.
- 14. No open fires or burning of any kind is permitted in the Parks.



- 15. Participation in any activity in the Parks that the District believes may create a danger to the public or may be considered a public nuisance is prohibited. The Board of Directors may designate particular locations within the Parks for specific activities. Certain facilities may require District permission or reservations.
- 16. Parks are not to be used for any purpose which violates State law, local or County ordinances or regulations, or administrative rules.
- 17. Reclaimed water from District's wastewater treatment plant shall be used for irrigation and make-up water in park ponds. Do not consume water, wildlife, or vegetation from the Parks. Catch and release fishing is permitted.

Any person entering the Parks agrees to release and hold harmless Harris County Municipal District No. 230, and/or its agents, from all damages and/or injuries.

Violation of any of the Park Rules will subject the violator to a fine of up to \$10,000 per violation or criminal penalties, including imprisonment, or both.

The Board and/or its agents, including the Harris County Sheriff's Office and District's Operator, shall be authorized to remove any person who violates any of these Park Rules.
